Sealed Bids for the construction of CKSD's proposed Athletic Electrical Improvements project will be received at the office of the School District at 531 Bedford Street, Claysburg, PA 16625, until 2:00pm local time on August 31, 2022, at which time the Bids received will be publicly opened and read. The Project includes one prime contract for Electrical Construction, which will be Contract 2 of a larger project. Work includes (but is not limited to) electrical distribution and appurtenances, trenching/backfilling, and wiring connections. Emailed or faxed bids will not be accepted.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 9:00 am and 4:00 pm and may obtain copies of the Bidding Documents from the Issuing Office as described below. There will be no pre-bid conference.

Only pdf versions of the Bidding Documents will be issued on flash drive via shipping service. Bidders will be responsible to print their own documents. There is no cost/deposit for the Bidding Documents themselves, and there is no shipping charge if the flash drive is picked up in person at the Issuing Office. A \$20 non-refundable shipping and handling charge will be added for shipping the flash drives, and payment shall be made payable to "Keller Engineers". The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. All bidders must be registered with the Issuing Office as a plan holder.

Bid security shall be payable to the Claysburg-Kimmel School District in the amount of ten percent (10%) of the bid price and in the form of certified or bank check or a bid bond issued by an acceptable surety and executed by the bidder. Bid bond will be returned to unsuccessful bidders if requested. The successful bidder will be required to furnish and pay for satisfactory performance and payment bonds.

Attention is called to the fact that not less than the minimum salaries and wages as set forth in the bidding requirements and contract documents must be paid on the project, and that the contractors must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin. All bidders are responsible for compliance with the Employee Verification Act of 2013. The Public Works Employment Verification Form must be completed before an award can be given. Claysburg-Kimmel School District reserves the right to reject any and all bids and to waive any and all informalities.
